- Return on investments:
 - Power Projects: 11.9%
 - Private Placements: 5.6%
 - Market Securities: (1.7)%
- Earned revenues of \$48 million
- Delivered \$31 million in benefits to residents and the region
- \$9 million in new business loans


Auditor's Report




for the year ending March 31

- 15% increase to the Community Initiatives and Affected Areas Programs in 2015/16
 - Kalso received \$36,225
 - Area D received \$114,530



- Kaslo City Hall Restoration \$150K
- Early Grey Trail Restoration \$20K
- North Kootenay Lake Community Services
 - Food Hub Renovation \$20K
 - Age-Friendly Project \$79K
- Assisting Seniors in Lardeau
 Valley \$15K
- Jazz Fest transition grant \$12K
 plus sponsorship




- Water Smart in Kaslo \$50K
 - achieved highest conservation results
 - a 39% reduction in water use as of 2015



- North Kootenay Lake Water Monitoring \$50K
 - innovative project to collect long-term water quality and quantity data to understand behavior of watersheds in Area D
 - helped raise awareness with local residents on potential impacts of climate change on local streams



- Meadow Creek Grizzly Bear Project
 - Reducing grizzly bear mortality and human-bear conflicts in Meadow Creek and Lardeau River areas by mapping bear activity, implementing non-lethal mgmt. techniques, and educating residents and visitors
 - Has led to a reduction in number and frequency of bear conflicts
 - \$100K since 2010



- Recreation Infrastructure Grants
 - Milford to Buchanan Traverse \$7K
 - Kaslo School & CommunityPlayground \$83K
 - Song Bird Loop Trail \$41K
 - Argenta Field of Dreams Grounds
 Improvement \$10K
- Broadband
 - 800 rural residents to benefit from improved high speed through KiN



- Kaslo & Up the Lake Youth Network
 \$165K for 3 years
 - will support activities and diverse opportunities based on local youth priorities, enabling youth aged 12-18 to learn new skills, and engage more with each other and their communities.
